

This privacy notice applies to the processing activities in relation to visitors of our website and individuals communicating with us.

### ***The type of personal information we collect***

We currently collect and process the following information.

When you are browsing our website, we collect and process:

- *Cookies* (detailed description regarding cookies you may find below).

When you communicating with us through our website, we collect and process:

- Information that you provide to us, such as your *name* and *email address*.

The data (name and your email address) is processed for the purpose of fulfilling a request from you or respond to your inquiries.

Your email and name is kept by Adwise only for such time periods as necessary to: fulfill a request from you or respond to your inquiries. Adwise has retention routines in place to ensure that personal data is deleted as required.

### ***Regarding cookies***

A cookie is a small text file that is placed on your computer, mobile phone, or other device when you visit a website. A cookie enables recognition of your computer and the collection of information on what websites and functions you have visited. It also helps maintain your settings when you are navigating a website or return to the same website at a later point.

We use the following types of cookies for the purposes explained below:

#### ***Legal bases for the processing***

The legal bases we rely on for processing abovementioned information are:

- Consent (for cookies);
- Legitimate interest (we use it to fulfill a request from you or respond to your inquiries).

Regarding **security**, we aim to ensure that you at all times remain confident in trusting Advise with your personal data, and Advise has implemented such security measures necessary to protect your personal data from unauthorized access, modification and deletion.

#### ***Your data protection rights***

Under data protection law, you have rights including:

*Your right of access* - You have the right to ask us for copies of your personal information.

*Your right to rectification* - You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.

*Your right to erasure* - You have the right to ask us to erase your personal information in certain circumstances.

*Your right to restriction of processing* - You have the right to ask us to restrict the processing of your personal information in certain circumstances.

*Your right to object to processing* - You have the the right to object to the processing of your personal information in certain circumstances.

*Your right to data portability* - You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.

*Your right to withdraw the consent*- In case you have given your consent to the use of cookies, you can easily withdraw your consent by writing to us using contact form.

*Your right to lodge a complaint* - For any enquiry or complaint regarding the treatment of your personal data, you can contact appropriate data protection authority in your country.
